Hi all – Tony B has advised its Leeds City region LEP . I have found the below on their website

The Leeds City Region Enterprise Partnership (the LEP) has created a £2 million recovery fund for businesses in Calderdale that were devastated by flooding following Storm Ciara.

The LEP, working in partnership with the West Yorkshire Combined Authority and Calderdale Council, has set up the Calderdale Business Flood Recovery Fund to help around 600 business affected. Most of those affected are small to medium sized firms specialising in retail, leisure and tourism – many of which were unable to insure their businesses following the Boxing Day floods in 2015. Emergency grants of up to £2,500 are available to help businesses

Emergency grants of up to £2,500 are available to help businesses cover short term costs such as replacing critical equipment, dehumidifying their premises and carrying out urgent repairs so they can get back on their feet quickly.

For businesses which have been hit harder, larger grants are available to help refurbish damaged premises and replace larger equipment such as machinery.

I will try and find out what funds the LEP has used to match the Council and CA funds and who the contact is leading on it . Kind regards Gill
